



## House Rules of Casino St. Moritz

St. Moritz 20.03.2022

### Admission

- All guests must identify themselves by means of an official identification document before any admission to Casino St. Moritz (Federal Gaming Law of 01.01.2019).
- The following identification documents are accepted: Swiss passport, Swiss identity card or driving licence, Swiss foreign national permit. Foreign passports, driving licences and EU identity cards are valid as identification documents, if these entitle the holder to enter Switzerland.
- No personal data is registered during admission checking, there is merely a check against the national register of excluded persons.
- The Casino Management exercises the house rights. It is entitled to refuse admission to persons without giving any reasons or to dismiss guests from Casino St. Moritz.
- The decision to deny admission to Casino St. Moritz is not permitted on grounds of discrimination regarding colour of skin or social origin.
- Dogs and other animals are not allowed to be brought into the Casino.
- The possession of weapons of any type within the Casino is forbidden.

### Minimum Age

Admission to Casino St. Moritz is allowed to those aged 21 and over.

### Dress Code

- The dress code is Smart / Neat Casual. We expect a standard of dress appropriate to the ambience of our Casino. Headwear is not permitted. Exceptions are allowed on religious grounds.
- The wearing of battle dress of the armed forces is not desirable in the Casino St. Moritz. The ceremonial uniform is however permitted.
- Casino St. Moritz reserves the right to refuse admission to anyone with inappropriate dress. Items of clothing such as raincoats and coats as well as briefcases and large handbags must be left at the cloakroom and are not permitted to be worn or carried within the Casino.

### Game Rules

The rules and regulations of the individual games are in our brochures. Our employees will be pleased to answer any further questions about the range of available games.

### Season Breaks

Casino St. Moritz is closing due seasonal break for several weeks during the year.

### Security

- We request all guests that they only leave the gaming table and/or gaming machines after any due winnings have been paid out or after there is no further credit on the machine.
- Action will be taken against unlawful use of gaming advantage.
- The rooms in Casino St. Moritz, particularly the gaming areas and their surroundings, are monitored permanently by video cameras. Gaming tables and cash desk are equipped with microphones for the security of the guests and the employees.
- The Management reserves the right to search the guests of the Casino St. Moritz for security reasons. This search may involve scanning the person by electronic metal detectors. Such security measures are taken exclusively for the protection and peace of all our guests.
- Casino St. Moritz assumes no liability for monies or items which are left unsupervised or left behind. Slot reservations are generally only possible for a short period (e.g. during the exchange process) and must be notified in advance to the employees.



### **Preventing addiction**

To guard against the potential of socially harmful consequences due to gaming activity and to prevent this where possible, Swiss casinos are bound to a social policy.

We refer to the Federal Gaming Law (SBG): Article 22 Gaming ban

The casino will exclude those persons from gaming activity, whom the casino, on the basis of their own observations in the Casino or on the basis of information from third parties, knows to be, or assumes to be, in such a position that they:

- a) are heavily indebted or are unable to meet their financial obligations.
- b) are risking gaming stakes, which bear no relationship to their income and assets.
- c) are impairing orderly gaming activity.

The players themselves can apply to the casino for a self-exclusion.

Should the Casino St. Moritz have reasonable grounds for supposing that a patron's income or assets do not permit him/her to play, or permit him/her only limited participation, it may refuse him/her admission. The law requires that this decision be communicated to all other casinos in Switzerland.

Admission may also be refused if the patron is insufficiently cooperative during clarification of his/her financial situation.

Please note the brochure "*Got your gambling under control?*", which is set up in the Casino St. Moritz.

### **Slot machines**

The maximum winnings from slot machines is CHF 25.000 per Slot machine and game, regardless of the amounts indicated on the machine. The above limitation of winnings shall not apply to the Mystery Jackpot. The Casino St. Moritz reserves the right to take a Slot machine out of service at any time.

### **Gaming Wagers**

Wagers on a credit basis (advances) are forbidden by law. Gaming bids (announcements) are only valid if the stated amount has been paid and if the gaming bid has been repeated loud and clear by the accepting croupier.

Guests must purchase their gaming chips to place stakes.

The wagers must be transacted in valid gaming chips from Casino St. Moritz.

The amount of the minimum and maximum wager for each of the games is displayed at the gaming tables or at the gaming machines.

For the security and benefit of our guests, chips circulated by Casino St. Moritz have no value outside the premises. Action will be taken against misuse.

In the event of any disputes with gaming activity or credit winning at the Slot machines, the Casino St. Moritz reserves the right, to withhold payments until the situation has been clarified

### **Gaming Chips**

Gaming chips are to be changed back before leaving the Casino.

The General Manager can remove gaming chips from circulation at any time, declare them as invalid and replace them with others.

Gaming chips without a value printed on them are to be credited with only the lowest chip value after account settlement at the table.

### **Roulette numbers**

The Casino assumes no liability for the accuracy of displayed or called numbers at the roulette table.

### **Currency**

Casino St. Moritz reserves the right to accept Swiss Francs only and the most important foreign currencies. Further information and details are given at the main cash desk. Where foreign currencies are exchanged a commission is charged.

### **Cheques**

No bearer cheques are accepted.

**Credit**

Casino St. Moritz does not grant any credit. Similarly, the granting of credit among the guests is not permitted.

**Photographing and Filming**

Filming or photographing is generally forbidden. The Casino Management is entitled to give permission on special request.

**Mobile phones**

It is not permitted to use mobile phones in the gaming areas, particularly at the gaming tables.

**Syndicate Gaming**

Syndicate gaming is strictly forbidden in Casino St. Moritz. The General Manager reserves the right where appropriate to declare the maximum wager limits per person.

**Jackpot Wins**

Jackpot wins up to CHF 30'000 are paid out in cash. A cheque can be issued for any sum which exceeds CHF 10'000. The encashments at the bank is subject to the provisions of the bank.

**Due Diligence regarding Money Laundering**

The necessary measures are strictly enforced to ensure that the requirements of the Federal Law against money laundering are met and that the reputation of the industry and its management are protected.

**Opening Times**

Casino St. Moritz is open daily (except for the seasonal breaks). During low season and summer season the opening times of the Table Game department is set up by the Casino St. Moritz Management and may contain less opening days. The opening times of the individual table games and Slot Machines can be established on an individual basis at the discretion of the Management. The current opening hours are communicated on the Casino Homepage.

The General Manager reserves the right to alter the opening times of the Casino at short notice by means of a pre-announcement.

**Technical Aids**

The use of technical or electronic aids to influence or record the games available is not permitted.

**Permitted Games**

Only games of chance are offered, which are permitted in accordance with the Federal Gaming Law.

**Drugs and other forbidden substances**

The use, sale, distribution and possession of illegal drugs and other forbidden substances is prohibited within the premises of Casino St. Moritz.

**Food and Drink**

In accordance with §25 of the Swiss Hotel & Catering Law, the sale of alcoholic drinks to persons who are drunk, mentally ill, dependent on alcohol or drugs is forbidden. No food or drink is permitted to be taken from the gaming and bar areas into the Reception of the Casino St. Moritz. Drinks purchased at the Casino bar can only be consumed within the Casino. No type of drink or food will be served after the bar closes.

**Right of Final Decision**

In cases of doubt, the General Manager has the right of decision or, in his/her absence, the Casino Management.

**Pay Out Confirmation**

The Casino St. Moritz does not issue pay out confirmation or any certificate of winnings.

**Employee tips**

84% of all tips are paid out to the employees of Casino St. Moritz in the form of salary additions. Gratuities of any other kind to employees are not permitted.

**Swiss Jackpot**

The operation of the Swiss Jackpot is governed by the regulations of the "Swiss Jackpot" limited casino partnership. If the Swiss Jackpot is triggered by several machines at the same time, whether in Casino St. Moritz or in another Swiss casino, the jackpot amount displayed is divided equally among the triggering players (no entitlement to the full jackpot amount displayed in the case of several winners). - In the event of uncertainty, the payment of the gaming balance may be withheld for clarification
